- A STATEMENT THAT **THIS IS NOT A LEGAL REQUIREMENT OF THE CITY OF FORT COLLINS.**

All painting of house numbers on curbs shall be done in accordance with the standard specifications as indicated. Promotional materials shall be provided to all persons contacted by the applicant for painting services authorized under this permit. (See back of this form for certain provisions of the City Code that may be applicable to this permit.)

Applicant agrees to abide by the current City of Fort Collins Standards and Specifications and to any special conditions, restrictions, and regulations as may be imposed by the Engineering Department.

## CHAPTER 24 STREETS AND SIDEWALKS

### ARTICLE III. STREETS

#### Sec. 24-92. House numbers on curbs.

(a) No person shall paint or otherwise install house numbers on the curbs of the City streets except as provided in this Section. The City Engineer shall develop standard specifications for the painting of house numbers on the curbs on public streets. Such specifications shall specify the size of any numbers to be used, the type of material to be used in applying such numbers to the curb and the color.

(b) Any person desiring to paint house numbers on curbs pursuant to this Section shall obtain a permit and make application for such permit to the City Engineer on a form to be supplied by the City Engineer. Any such permit shall be valid through December 31 of the year of its issuance. No such permit shall be issued until the applicant has submitted to the City Engineer copies of all promotional materials intended to be used in the business authorized pursuant to the permit, which promotional material shall contain the name, address and telephone number of the permittee; the price to be charged for the painting services; a statement that all painting services performed under the permit are performed as a private service of the vendor and not as a project of the City; and that it is not a legal requirement of the City that house numbers be painted on curbs. Said promotional materials shall be provided to all persons contacted by the applicant for painting services authorized under the permit. The City Engineer is hereby authorized to promulgate such further rules and regulations as are reasonably necessary to effectuate the enforcement of this Section.

## CHAPTER 15 LICENSES AND BUSINESS REGULATIONS

### ARTICLE IV. AUCTIONS SPECIAL SALES AND SOLICITATIONS\*

#### Sec. 15-106. Residential solicitations prohibited; exceptions.

No person shall enter or remain upon any residential premises in the City, not having been requested or invited by the occupant(s) thereof, for the purpose of contacting said occupants to solicit the immediate or future purchase or sale of goods, services or any other thing of value. The provisions of this Section shall not apply to charitable, religious or political solicitations or the solicitation of newspaper or magazine subscriptions unless a "No Solicitation" or "No Trespassing" sign is posted at or near the entrance(s) to such residence.

#### Sec. 15-107. All solicitations prohibited by posting of "No Solicitation" or "No Trespassing" sign.

No person shall enter or remain upon any public or private premises in the City, not having been requested or invited by the occupant(s) thereof, for the purpose of soliciting the immediate or future purchase or sale of goods, services or any other thing of value, or to solicit a gift or donation when a "No Solicitation" or "No Trespassing" sign is posted at or near the entrance(s) to such premises. This provision shall apply to all solicitations, including, without limitation, those that are charitable, religious or political in nature.

#### Sec. 15-108. Attempt to obtain invitation prohibited.

No person shall attempt to obtain, by telephone or otherwise, an invitation to visit any private residence for the purpose of soliciting the purchase or sale of goods, services or any other thing of value, by knowingly making a false or deceptive representation or statement.
